2. Enclose \$150.00 for booth fee, made payable to Fine Line Designs, **(non-refundable upon acceptance.)**

3. Provide a business size, **self-addressed, stamped envelope** for notification and return of submission materials.

4. Enclose 4 photographs or a pen drive of images (1 of display) representational of the pieces you intend to sell. Place your name on material for identity.

5. **Calendar Deadlines:** Images due June 1st/**category full.** Enclose a SASE for confirmations. **Categories are juried until full.**

RULES:

1. All work that is to be exhibited must be original in concept and executed by the applying artist. Work that is displayed at the Townline Art Fair must be represented by the slides that accompanied application. No commercial kits, molds, patterns, plans, stencils or prefabricated forms. The Townline Art Fair committee reserves the right to refuse any artist the right to exhibit work not in the same media or not complying with the stated requirements.

2. Fine Line Designs Gallery cannot assume any liability in case of loss, liability or damage to work from any cause. Insurance responsibility is left to the Artist.

3. There is no camping on the fair grounds.

4. Any artist who disassembles display before show hours are complete or without permission from event coordinator will not be invited back. Artist must be onsite during show hours. NO EXCEPTION!

SPACE & SET UP:

Size of spaces are approximately 10' x 10'. Artist is to provide display & shelters appropriate for outdoor shows.

Set up time is anytime after 2:00 on Friday,

October 11th. Show hours are **10-5 Saturday and 10-4 Sunday. Sunday is required.** Artists not participating on Sunday will not be invited back.
